| 14 | (2) "Governing authority" means the board of trustees of a school district or the administrator of a |
| 15 | private school, preschool, or postsecondary school. |
| 16 | (3) "Immunity" means a state of resistance to a given disease. |
| 17 | (3)(4) "Immunization" means induction of a state of resistance to a disease, either due to infection |
| 18 | with and recovery from a disease or through administration of an immunizing agent. |
| 19 | (5) "Immunizing agent" means an antigen introduced through a vaccine, through immunotherapy, or |
| 20 | through homeoprophylaxis that stimulates immunity without inducing the disease itself. |
| 21 | (4)(6) "Local health department" means a city, city-county, county, or district health department. |
| 22 | (5)(7) "Local health officer" means a city, city-county, county, or district health officer. |
| 23 | (6)(8) "Postsecondary school" means a community college, a unit of the Montana university system, |
| 24 | or a private university or college. |
| 25 | (7)(9) "Preschool" means a place or facility that provides, on a regular basis and as its primary |
| 26 | purpose, educational instruction designed for children 5 years of age or younger and that: |
| 27 | (a) serves no child under 5 years of age for more than 3 hours a day; and |
| 28 | (b) serves no child 5 years of age for more than 6 hours a day. |
